PSHE Relationships and Sex Education Policy



Article 2 (non-discrimination) The Convention applies to every child without discrimination, whatever their ethnicity, gender, religion, language, abilities or any other status, whatever they think or say, whatever their family background.

Article 6 (life, survival and development) Every child has the right to life. Governments must do all they can to ensure that children survive and develop to their full potential.

Article 12 (respect for the views of the child) Every child has the right to have a say in all matters affecting them, and to have their views taken seriously.

Article 13 (freedom of expression) Every child must be free to express their thoughts and opinions and to access all kinds of information, as long as it is within the law.

Article 17 (access to information from the media) Every child has the right to reliable information from a variety of sources, and governments should encourage the media to provide information that children can understand. Governments must help protect children from materials that could harm them.

Article 24 (health and health services) Every child has the right to the best possible health. Governments must provide good quality health care, clean water, nutritious food, and a clean environment and education on health and well-being so that children can stay healthy. Richer countries must help poorer countries achieve this.

WHAT IS RELATIONSHIPS AND SEX EDUCATION?

It is lifelong learning about physical, moral and emotional development. It is about the understanding and nature of healthy relationships and the importance for family life. It should help children understand the difference between safe and abusive relationships. It is not about the promotion of sexual orientation or sexual activity, this would be inappropriate teaching. (DFES and RSE policy Guidance)

1. Aims

At Blanford Mere we treat children as individuals and are concerned with all aspects of their development: academic, social, spiritual and physical, preparing them to become valued members of the local community, of which the school is a part, and the wider society.

The aims of relationships and sex education (RSE) at our school are to:

- > Provide a framework in which sensitive discussions can take place
- ➤ To learn about their bodies and to recognise if other people make them feel uncomfortable or unsafe and know how to get help if they need it (see the 'Underwear Rule', a Childline initiative. See Appendix 3).
- Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene
- ➤ Help pupils to develop feelings of self-respect, confidence and empathy
- Create a positive culture around issues of sexuality and relationships
- > Teach pupils the correct vocabulary to describe themselves and their bodies

We aim to foster respect for themselves and others so that everyone feels valued and secure in our school and wider community. We encourage children to have high aspirations and strive to be the best that they can be, so that they can make a positive contribution to modern Britain. We also aim to create a happy and caring community with involvement and commitment from children, staff and parents/carers to support children's learning.

2. Statutory Requirements

From September 2020 Relationship Education and Health Education becomes compulsory for all pupils receiving primary education. 'The Relationships Education, Relationships and Sex Education and Health Education (England) Regulations 2019, made under sections 34 and 35 of the Children and Social Work Act 2017, make Relationships Education compulsory for all pupils receiving primary education and Relationships and Sex Education (RSE) compulsory for all pupils receiving secondary education.

As a maintained primary school we must provide relationships education to all pupils as per section 34 of the Children and Social work act 2017.

However, we are not required to provide sex education but we do need to teach the elements of sex education contained in the science curriculum.

In teaching RSE, we must have regard to <u>guidance</u> issued by the secretary of state as outlined in section 403 of the <u>Education Act 1996</u>.

At Blanford Mere we teach RSE as set out in this policy.

3. Policy Development

This policy has been developed in consultation with staff, pupils and parents. The consultation and policy development process involved the following steps:

- 1. Review a working group of local schools worked together to consider all relevant information including statutory national and local guidance.
- 2. Staff consultation all school staff were given the opportunity to look at the policy and make recommendations
- 3. Parent/stakeholder consultation parents and any interested parties were invited to read the policy and respond with their comments and thoughts
- 4. Pupil consultation we investigated what exactly pupils want from their RSE
- 5. Ratification once amendments were made, the policy was shared with governors and ratified

4. Definition

RSE is about the emotional, social and cultural development of pupils, and involves learning about relationships, health & hygiene, healthy lifestyles, diversity and personal identity.

RSE involves a combination of sharing information and exploring issues and values.

RSE is **not** about the promotion of sexual activity.

5. Curriculum

Our curriculum is set out as per Appendix 1 but we may need to adapt it as and when necessary.

We have developed the curriculum in consultation with parents, pupils and staff, taking into account the age, needs and feelings of pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so they are fully informed and don't seek answers online. This may include working in partnership parents and families to ensure children are kept safe.

Primary health education will focus on preparing boys and girls for the changes that adolescence brings. Sanitary protection is available from any of the Key Stage 2 classroom staff. Sanitary disposal units are situated in the Key Stage 2 girls' toilets. Children will be informed of this during sessions on puberty in Years 5 and 6.

PSED in the Early Years is particularly crucial for igniting children's curiosity and enthusiasm for learning, and for building their capacity to learn, form relationships and thrive. Personal, social and emotional development involves helping children to develop a positive sense of themselves, and others; to form positive relationships and develop respect for others; to develop social skills and learn how to manage their feelings; to understand appropriate behaviour in groups; and to have confidence in their own abilities

For more information about our curriculum, see our curriculum map in Appendix 1 and the Statutory Framework for the Early Years Foundation Stage.

This policy should be read in conjunction with the Computing policy, Science policy (and curriculum overview outline) Safeguarding policy, Behaviour Policy, Keeping Children Safe in Education 2020, the E Safety policy, Drugs and Alcohol policy and the School Code of Conduct.

6. Delivery of RSE

RSE is taught within the personal, social, health and economic (PSHE) education curriculum. Biological aspects of RSE are taught within the science curriculum, and other aspects are included in religious education (RE).

As a whole school we will be using the DFE approved PSHE Association materials, along with high quality resources to support our RSE provision; these will be regularly reviewed.

In addition to this the children will be introduced to the 'Underwear rule', a Childline initiative, to help them recognise if other people make them feel uncomfortable or unsafe. Children will be taught how to get help if they need it. This will be initially introduced in Nursery and Reception classes and will be referred to throughout school. See appendix 3.

Pupils will also receive stand-alone sessions delivered by trained professionals, for example the School Nurse. We also provide support from 'Loudmouth'. Loudmouth Education and Training is a highly respected and innovative theatre in education company. Loudmouth provides a range of programmes that support relationship and health education. Loudmouth's work aims to ensure a future where all children and young people are healthy, happy, safe and resilient.

Relationships education focuses on teaching the fundamental building blocks and characteristics of positive relationships including:

- > Families and people who care for me
- Caring friendships
- > Respectful relationships
- Online relationships
- > Being safe

For more information about our RSE curriculum, see Appendices 1 and 2.

These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively

that some children may have a different structure of support around them (for example: looked after children or young carers).

We will ensure a safe learning environment by agreeing ground rules at the start of each session and handling any issues sensitively.

Soft starts

All children will begin each day with the opportunity to calm their minds in preparation for their learning that day. The following terms will be used:

Meditation Monday

Talking Tuesday

Wellbeing Wednesday

Thoughtful Thursday

Fun Friday

This wellbeing initiative will give the children time to reflect and learn how to cope with their feelings on a daily basis.

The emotional and physical benefits can include:

- Gaining a new perspective on stressful situations
- Building skills to manage your stress
- Increasing self-awareness
- Focusing on the present
- · Reducing negative emotions
- Increasing imagination and creativity
- Increasing patience and tolerance
- Lowering resting heart rate
- Lowering resting blood pressure
- Improving sleep quality

7. Key Vocabulary

The following key vocabulary will be introduced in the following year groups.

Year 2: penis, vagina

Year 5: vulva, testicles

Year 5: lesbian, gay, bisexual, transgender

8. Safeguarding

Throughout school children will be encouraged to use the correct terminology for genitalia. It is important for younger children to know how to name their body parts correctly as this contributes to safeguarding – helping them to take care of their bodies and keep themselves safe.

Teachers are aware that sometimes a disclosure may be made, in which case the safeguarding policy will be followed. At times it is clear that some children will need one to

one support after the session to talk further. We will allow the time and staffing for this to happen.

Sometimes an individual child may ask an explicit or difficult question in the classroom. Questions do not have to be answered directly, and can be addressed individually later. This school believes that individual teachers must use their skill and discretion in these situations and refer to the PSHE Subject Leader or Senior Leadership Team if they are concerned.

8. Diversity and Inclusion

It is essential that the teaching of RSE is sensitive to the range of religious and cultural views about sexual behaviour whilst still ensuring that pupils have access to the learning they need to stay safe, healthy and understand their rights as individuals. This will include clear, impartial scientific information on matters such as the changes of puberty, as well as covering the law in relation to, for example, forced-marriage and female genital mutilation (FGM).

The concept of equality and legislation relating to RSE lies at the heart of our Rights Respecting work and fosters gender and LGBT+ equality, challenging all forms of discrimination and bullying. The teaching of RSE must be respectful of how pupils choose to identify themselves, understanding that their sexual orientation and gender identity may be 'emerging'.

The needs of all pupils, with their diverse experiences, including those with special educational needs and disabilities (SEND) will be considered at all times. Teaching staff will have a good understanding of the needs of the pupils in their class. They will use the SEN/EHCP plans, internal and external support agencies that have been put in place, to ensure informed, reasonable adjustments and appropriate resources, pre learning etc is available prior to sessions commencing. Staff can also seek support from the SEND coordinator. They will also liaise with the child's parents/carers, if necessary, as they can provide a valuable insight into the most appropriate approach to working with their child.

9. Remote Learning

Remote learning for RSE will be shared with families when they are absent due to the Covid related reasons.

Remote learning will not be available to those who are ill with a non-Covid related illness and would not normally attend school, or to those children whose parents choose to keep them at home when they have not been advised to do so. This is because children need to be in school and, in line with Government guidance, the school will strongly promote face-to-face contact through school attendance.

Work will NOT be set on the first day of isolation to allow staff time to prepare. Work will be sent from the second day onwards. Staff will prepare work the day before it is set and will ensure that it is published the following morning.

 A child who has a member of their household, who has tested positive for Covid-19 and are not permitted to attend school because they have been in close contact and have been advised to self-isolate;

- A child's whole bubble or identified pupils who is not permitted to attend school because they, or another member of their bubble, have tested positive for Covid-19.
- A child unable to attend school due to a local or national lockdown

10. Roles and Responsibilities

10.1 The governing board

The governing board will approve the RSE policy, and hold the headteacher to account for its implementation.

10.2 The headteacher

The headteacher is responsible for ensuring that RSE is taught consistently across the school.

10.3 Staff

Staff are responsible for:

- Delivering RSE in a sensitive way
- ➤ Modelling positive attitudes to RSE
- Monitoring progress
- > Responding to the needs of individual pupils

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the headteacher.

All staff are responsible for teaching RSE in this school.

10.4 Pupils

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity. As a Rights Respecting school, children are aware that everyone has a right to express their opinion, but in a way that does not offend others.

11. Parents' right to withdraw

The statutory guidance states that parents do not have the right to withdraw their children from Health or Relationships education. The DfE have made it clear in their guidance that all children should receive this content, so that they are equipped with the knowledge, skills and understanding to be positive members of our diverse community.

The Science curriculum in all maintained schools also includes content on human development, including reproduction, which there is no right to withdraw from.

12. Training

Staff are trained on the delivery of RSE as part of their induction and it is included in our continuing professional development calendar.

The headteacher will also invite visitors from outside the school, such as school nurses or other professionals, to provide support and training to staff teaching RSE.

13. Monitoring Arrangements

The delivery of RSE is monitored by the PSHE leader, Mrs J Cartwright and the Senior Leadership Team

Teachers will critically reflect on their work in delivering RSE through regular staff and phase meetings.

Pupils will have opportunities to review and reflect on their learning during lessons and pupil voice will be influential in adapting and amending planned learning activities.

Pupils' development in RSE is monitored by class teachers as part of our internal assessment systems.

This policy will be reviewed by the PSHE leader, Mrs J Cartwright annually. At every review, the policy will be approved by the governing board.

Appendix 1: Curriculum Overview

EYFS Statutory Framework (1st September 2021)

Personal, Social and Emotional Development

Children's personal, social and emotional development (PSED) is crucial for children to lead healthy and happy lives, and is fundamental to their cognitive development. Underpinning their personal development are the important attachments that shape their social world. Strong, warm and supportive relationships with adults enable children to learn how to understand their own feelings and those of others. Children should be supported to manage emotions, develop a positive sense of self, set themselves simple goals, have confidence in their own abilities, to persist and wait for what they want and direct attention as necessary. Through adult modelling and guidance, they will learn how to look after their bodies, including healthy eating, and manage personal needs independently. Through supported interaction with other children, they learn how to make good friendships, co-operate and resolve conflicts peaceably. These attributes will provide a secure platform from which children can achieve at school and in later life.

- Show an understanding of their own feelings and those of others, and begin to regulate their behaviour accordingly;
- Set and work towards simple goals, being able to wait for what they want and control their immediate impulses when appropriate;
- Give focused attention to what the teacher says, responding appropriately even when engaged in activity, and show an ability to follow instructions involving several ideas or actions.

- Be confident to try new activities and show independence, resilience and perseverance in the face of challenge;
- Explain the reasons for rules, know right from wrong and try to behave accordingly;
